

Abbreviated General Policy and Procedures

(go to website for official document)

- ✓ NO alcoholic beverages or controlled substances are permitted on club grounds.
- ✓ Lock the entrance gate upon entering and leaving except during scheduled events.
- ✓ Sign In and Out at the shed every time using the club grounds.
- ✓ A signed **Release from Liability** form (blank forms located in the shed) must be on file for every person on club grounds.

 IF IN DOUBT, FILL ONE OUT.
- ✓ All members must wear their photo ID badges.
- ✓ Pets are allowed on club grounds. The animal must be under physical or voice control at all times. The club member must clean-up after the animal.
- ✓ The RED range flag must be raised on the flag pole during any live fire.
 - ***** Eye and Ear Protection devices are required.
- ✓ Any abuse or misuse of club property is grounds for immediate disciplinary action and may be criminally prosecuted.
- ✓ Fishing is permitted on a Catch and Release basis.
- ✓ Walk-in tent camping seven (7) day limit; no monthly or seasonal camping is allowed.
 - **★** Quiet hours are from 11:00 pm to 8 am.
 - **★** Cutting or gathering live wood is **prohibited**.
 - **★** Camp fires are only allowed in designated fire rings.
